Personals Store Terms of Service

Updated: 21 January 2013

By purchasing content from a model's Personals store (hereafter Personals), you are agreeing to be bound by this Terms of Service (TOS).

In addition to the following terms, you are solely responsible for following all applicable laws and regulations in your location. If you do not agree with the terms within this document, you will be prohibited from purchasing content in the Personals.

1. General Terms

- **1.1.** You are 18 years of age or older and that you are not prohibited by your local laws from accessing adult material.
- **1.2.** You will only access content allowed by FreeOnes. If you come across prohibited material, you will immediately mail webmaster@freeones.com to report said content.
- **1.3.** You will only use the material you purchase for your own personal use.
- **1.4.** You will not ask for a refund on unspent credits as they have no cash value.

2. Personals User Agreement

FreeOnes provides the service of the Personals store for its registered members. If you are not a FreeOnes member, you may register free of charge at http://board.freeones.com/register.php.

- **2.1. Grant of Limited License:** FreeOnes grants you a limited, nonexclusive, and nontransferable license to use its software and materials made available to you. The materials are for your personal non-commercial use.
- **2.2. Models' Personals:** You understand and agree that the content in the Personals is posted by 3rd parties and FreeOnes is not responsible for the material that is posted. If any material represents illegal or forbidden content, please report this to webmaster@freeones.com immediately.
- **2.3. Downloading Material:** By downloading material from the Personals, you agree that the sale is final and non-refundable unless the specific conditions found in the Transactions and Refunds section (Section 4) are met.
- **2.4. Use of Material:** By purchasing Personals material, you explicitly agree that the material is for your own personal use only. Further, you agree you will not resell or distribute the material to other FreeOnes members or 3rd parties without the permission of the intellectual copyright holder.
- **2.5. Deletion of Material:** You agree that FreeOnes may delete any Personals material that violates the terms the individual models agree to or does not work. Additionally you agree FreeOnes may delete any material at any time, for any purpose, without prior notification or refund to you.

3. FreeOnes Credits

By purchasing material from the Personals, you agree that:

- **3.1.** All sales and transactions in regards to FreeOnes credits are final.
- **3.2.** FreeOnes credits have no cash value and are for entertainment use only.

- **3.4.** FreeOnes staff may modify the amount of credits in your account at any time, for any reason, without prior notice to you.

4. Transactions and Refunds

All sales made through the Personals are final. Refunds for Personals material will only be issued in the cases outlined below, at the discretion of FreeOnes. Before issuing any refund, FreeOnes will make a reasonable attempt to fix the issue so you may receive the material you attempted to purchase.

- **4.1.** The following material is considered forbidden content. If you find this content in the Personals store, please report it to webmaster@freeones.com.
 - **4.1.1.** Material depicting minors, or simulating minors
 - **4.1.2.** Snuff
 - **4.1.3.** Necrophilia
 - **4.1.4.** Gore or blood (simulated or real)
 - **4.1.5.** Bestiality
 - **4.1.6.** Crushing of animals/insects/body parts
 - **4.1.7.** Forced sex or simulated rape
 - 4.1.8. Sleeping or drugged
 - **4.1.9.** Scat (feces)
 - **4.1.10.** Hypnosis
- **4.2.** You clicked the 'Get this content' button, the credits deducted from your account, but you did not receive the material.
- **4.3.** The material you purchased was uploaded by the model as a corrupted file, or broke during the upload process.
- **4.4.** The material is misrepresented by the model. This means that the material was labeled in one category, but had nothing to do with the category it was labeled under. Please note that this does not mean that the material you purchase must contain every element of the sexual act in the category. The material must be completely irrelevant to the category to be issued a refund.

5. Termination of Your Account

Your account may be terminated at any time, at your request. It also may be terminated by

FreeOnes, at its discretion, at any time for any reason without prior notice to you. Additionally, in the case of account termination, you agree that:

- **5.1.** Unused credits will not be refunded.
- **5.2.** Material that you purchased will not be stored, it will be deleted upon your account termination.
- **5.3.** In the event of termination by FreeOnes, you will not create a new account or use the account of another member for the purpose of purchasing Personals material.
- **5.4.** Members with multiple accounts, that are caught cheating in order to gain more credits, will be terminated immediately and without prior notice.
- **5.5.** If your account is terminated, by your request or by FreeOnes, you agree that FreeOnes will not be held liable to you or any third party for the termination of your access to the Personals or any other part of FreeOnes requiring membership.

6. General Provisions
